

Since its inception, NDMA has taken several initiatives and programmes in strengthening disaster preparedness and mitigation, improving disaster response and recovery, and supporting capacity-building activities in the country.

Disasters, whether natural or man-made, pose significant challenges to public health, including the spread of diseases, injuries, and the disruption of healthcare systems. Public health issues affect the disaster-affected communities in multiple ways, disrupting their lives and livelihoods. Women, children, and elderly are seriously affected, necessitating prompt health and medical interventions.
